

Section No. 3. Basic Tariffs for the Remote Banking Service System for Individuals, Legal Entities, and Individual Entrepreneurs.

Notes :

- All fees mentioned in this document are effective at the time of the conclusion of the agreement and may be revised by the Bank unilaterally.
- All fees are charged in the national currency of the Kyrgyz Republic or in the account currency at the exchange rate of the National Bank of the Kyrgyz Republic on the date of the transaction.
- All fees are indicated inclusive of all taxes and charges in accordance with the current legislation of the Kyrgyz Republic.
- The Bank has the right to additionally charge fees of other banks and other third-party fees arising in the course of performing the client's transactions.
- The Bank reserves the right to modify and set individual tariffs.
